MINUTES

The monthly meeting of the Board of Directors of the East Donegal Sewer Authority was called to order on June 15, 2010 at 7:00 p.m. by Chairman Mr. Jim Miller.

NO PUBLIC COMMENT

Mr. Philip Rudy – White Rudy & Company LLP presented the audit report for the year ended December 31, 2009. Mr. Rudy reviewed the audit report and issued an unqualified opinion. The Authority's financial statements show the Authority is in a strong financial position. Mr. Smeltz made a motion to accept the financial statements for the year ended December 31, 2009. Seconded by Mr. Dombach. Motion carried unanimously.

Ms. Boyer discussed two noise problems with manholes in Maytown - one is located on the Square and the other on High Street. Roger Richards has presently placed Ram Neck around each of the manholes and at this time they are not making noise. The manhole on square is cracked and will need to be replaced in the future. There is also a manhole on Coffee Goss Road that is making noise and the Board instructed Mr. Richards to place Ram Neck on this manhole. The Board decided to wait and see how long the Ram Neck works before making any other decisions.

The minutes of the Board meeting of May 18, 2010 were approved with a motion made by Mr. Dombach and seconded by Mr. Smeltz. Motion carried unanimously. Mr. Miller abstained as he did not attend the May meeting.

Mr. Shireman reviewed the pumping stations for the month of June:

1. <u>Lacey Agreement</u> - The Lacey Agreement expired June 30, 2009. The Board discussed various options to renew the agreement. The Board asked Ms. Grey to contact the solicitor for Marietta Borough and propose to extend the agreement for 10 years to renew automatically unless a six month notification is given by the Borough or the Authority and that semi-annual payments be paid to Marietta Borough.

Ms. Boyer reported to the Board that \$61,150.69 was transferred from the Investment Account into the Revenue Account and \$300,000 was transferred from the Revenue Account into the PLGIT I/Class Account.

Ms. Boyer reported to the Board that a CD matured from UNCB and an CD was purchased from PLGIT in the amount of \$200,000 at an interest rate of 1.078%
