The Board's Minutes of the East Donegal Township Board of Supervisors Held on June 6, 2013

The regular meeting of the Board of Supervisors of East Donegal Township was held on Thursday, June 6, 2013 at 7:30 PM in the East Donegal Township Municipal Building, 190 Rock Point Road, Marietta, PA 17547.

The meeting was called to order by Supervisor Dennis Drager.

Roll call of Supervisors: Present were Dennis J Drager, Chairman; Allen D. Esbenshade, Vice Chairman; John Murphy, Member.

Public attendance is attached.

Supervisor Esbenshade opened the meeting with a Prayer and Pledge to the Flag.

An opportunity was given for the public to make comments on items included or not included on the agenda.

Ms. Chris Wallander, Mr. Walt Wallander, Mr. Halbleib and Ms. Linda Bond were present to inquire about Township regulations governing the parking of boats and boat trailers on public streets. All are residents in Longwood Square. They indicated that another resident of the neighborhood has parked a large boat and jet ski on the street for an extended period of time without moving it. Ms. Bond indicated that it creates a hazard for her to back out of her driveway.

The residents were informed that the Township currently does not have an ordinance prohibiting the parking of boats and boat trailer on public streets. However, the police may have the ability to address the situation in instances where the trailer is unregistered and/or uninspected. Sargent Rapp of the Susquehanna Regional Police Department was present and gathered information form the residents regarding the issue. Sargent Rapp returned to the meeting and indicated that he spoke with the owner of the boat and jet ski and that the owner agreed to move them from the street.

Ms. Linda Good and Ms. Pat Vogel were present to discuss the placement of the bell and bell tower from the Maytown Elementary School on Township property. The bell and tower were received by the Township from the Maytown Historical Society.

Ms. Good and Ms. Vogel stated that they, along with a few members of the Township Park Commission met to discuss potential locations for the bell. The locations discussed were; affixed to the scoreboard at the lighted baseball field in Fuhrman Park, mounted on top of the sign located in front of the Township building, or locating the bell and tower in the area of the park surrounding the gazebo. Although the group was working to find a location for the bell, they did not formulate a single recommendation to present to the Board of Supervisors. The Board indicated they will review the information submitted and make a decision at a future meeting.

The Board approved the minutes for May 2, 2013 by a motion made by Mr. Esbenshade and seconded by Mr. Murphy. Discussion: None. Vote: Mr. Murphy; yes, Mr. Esbenshade; yes, Mr. Drager; yes. Motion carried.

A motion was made by Mr. Esbenshade and seconded by Mr. Murphy to approve the Treasurer's Reports for the Township and Maytown East Donegal Township Fire Department and approve the payment of all bills. Discussion none. Vote: Mr. Murphy; yes, Mr. Esbenshade; yes, and Mr. Drager; yes.

Chairman Drager acknowledged the receipt of the Balance Sheets with a printed date of May 10, 2013 for all Township Funds which were provided to each Supervisor.

Consent Calendar:

Chairman Drager called for comments on items on the Consent Calendar.

Mr. Murphy inquired about the proposal to survey the Longwood Square Park property, item D on the Consent Calendar. In was indicted that during the 2013 budget discussions regarding the paving of the walking trail, the number of possible intrusions of neighboring property owners with fences and landscaping was identified. These intrusions make park maintenance more difficult. Following the completion of the survey, neighbors will be notified to address intrusion onto the park property.

Mr. Murphy asked about the need to update the Township's Stormwater Management Plan, item G on the Consent Calendar. Mr. Butler explained the adoption of the Lancaster County Act 167 Stormwater Management Plan and the requirement of the Pennsylvania Department of Environmental Protection that the Township adopt regulations to implement the Plan by November 21, 2013. The Board expressed concerns regarding the impact of new regulations on smaller projects that currently do not address stormwater management.

A motion was made by Mr. Murphy and seconded by Mr. Esbenshade to approve the following Consent Calendar items, "A" through "H". Vote: Mr. Murphy; yes, Mr. Esbenshade; yes and Mr. Drager; yes. Motion carried.

- A. Ratified the action to send letter of support for the University of Maryland's Small Watershed Grant Proposal regarding the Lancaster County Municipal Stormwater Financing Initiative (Round 2). The Small Watershed Grant Initiative is a program of the National Fish & Wildlife Foundation.
- B. Approved the time extension for Township action on the Preliminary Subdivision Plan for Route 441, LP prepared by Steckbeck Engineering and Surveying, Inc., dated September 20, 2012. The Township shall have until October 4, 2013 which to consider action on the plan.
- C. Approved the time extension for Township action on the Marietta DPP VII, LLC Final Subdivision and Land Development Plan– prepared by Steckbeck Engineering and Surveying, Inc., dated October 18, 2012. The Township shall have until October 4, 2013 which to consider action on the plan.
- D. Approved execution of the David Miller/Associates, Inc. Proposal for Professional Services P13-82 regarding the survey of the Longwood Square Park and setting of missing perimeter corner

- markers. The 1.7 acre park property has numerous potential encroachments from adjacent residential properties.
- E. Approved the following applicants for employment in the Township Summer Playground Program, as recommended by the Township Park Commission.

- F. Approved the Improvement Guarantee release for Spectra Energy Stormwater Management Plan, 1588 Depot Road. Current Account Balance is \$20,000.00. The amount of the reduction recommended by the Township Engineer is \$15,000.00. The remaining balance of \$5,000.00 secures the completion of items indicated in the June 6, 2013 letter from David Miller/Associates, Inc.
- G. Directed the Township Manager and Township Engineer to prepare the necessary ordinances and regulations necessary to regulate development within the Township in a manner consistent with the Stormwater Management Plan for Lancaster County, as approved by the Pennsylvania Department of Environmental Protection, and the provisions of the Pennsylvania Stormwater Management Act 167. In accordance with the requirements of Act 167, the ordinance regulating stormwater management, consistent with the Stormwater Management Plan for Lancaster County and Act 167 must be adopted by November 21, 2013.
- H. Approved the Improvement Guarantee release for Harold Martin (Eli Fisher) Final Subdivision Plan. Current Account Balance is \$23,959.08. The amount of the reduction recommended by the Township Engineer is \$10,000.00. The remaining balance of \$13,959.08 secures the completion of items indicated in the June 6, 2013 letter from David Miller/Associates, Inc.
