## The Board's Minutes of the East Donegal Township Board of Supervisors Held on March 7, 2013

The regular meeting of the Board of Supervisors of East Donegal Township was held on Thursday, March 7, 2013 at 7:30 PM in the East Donegal Township Municipal Building, 190 Rock Point Road, Marietta, PA 17547.

The meeting was called to order by Supervisor Dennis Drager.

Roll call of Supervisors: Present were Dennis J Drager, Chairman; Allen D. Esbenshade, Vice Chairman; John Murphy, Member and Joyce Boyer, Township Treasurer.

Public attendance is attached.

Supervisor Murphy opened the meeting with a Prayer and Pledge to the Flag.

Matthew Stewart, Scoutmaster BSA Troop 16 addressed the request of the Harvest District of the Pennsylvania Dutch Council, Boy Scouts of America's for use of Riverfront Park for a weekend-long event. The event would be held October 4-6, 2013. Mr. Stewart indicated he will be meeting with the Park Commission regarding the request.

The Board approved the minutes for February 7, 2013 by a motion made by Mr. Esbenshade and seconded by Mr. Murphy. Discussion: None. Vote: Mr. Murphy; yes, Mr. Esbenshade; yes, Mr. Drager; yes. Motion carried.

A motion was made by Mr. Esbenshade and seconded by Mr. Murphy to approve the Treasurer's Reports for the Township and Maytown East Donegal Township Fire Department and approve the payment of all bills. Discussion none. Vote: Mr. Murphy; yes, Mr. Esbenshade; yes, and Mr. Drager; yes. Motion carried.

Chairman Drager acknowledged the receipt of the Balance Sheets with a print date of February 14, 2013 for all Township Funds which were provided to each Supervisor.

Chairman Drager called for comments on items on the Consent Calendar.

A. Approved the annual contribution of \$7,755.00 to the Lancaster County Drug Enforcement Task Force. The amount of the contribution represents \$1.00 per Township resident.

- B. Approved the request of American Legion Post #809 for funding in the amount of \$4,414.00 for expenses associated with the 2013 Memorial Day Parade.
- C. Approved directing the Township Roadmaster to advertise to receive bids for the Endslow Road and Rock Point Road roadway improvement projects.
- D. Adopted Resolution 2013-4, Resolution For Plan Revision For New Land Development for Gerald L. and Joanne L. Hess, 1404 Donegal Springs Road.
- E. Approved the Final Subdivision Plan for James F. and Frances R. Houseal, prepared by D.C. Gohn Associates, Inc., dated 10/01/2012, last revised 02/28/2013, and granted the following modifications to Township requirements:

Williamson, Program Manager, Wetlands and Waterways Program, of the Pennsylvania Department of Environmental Protection, approving the Lancaster County Act 167 Stormwater Management Plan, subject to conditions, and to further authorize the Solicitor and appropriate Township officials to execute other documents necessary or desirable to prosecute the appeal.

Maytown-East Donegal Township Fire Department: For the month of January 2013 the Department handled 44 calls in the Township and 9 mutual aid calls were handled making a total of 53 calls.

Northwest Emergency Medical Services, Inc Report: The ambulance and MICU activity for January 2013 was 46 calls. The ambulance and MICU activity for February 2013 was 49 calls.

Fire Department Mount Joy Report: For February 2013 the Fire Department responded to 1 First Due calls and 0 Mutual Aid calls in East Donegal Township.

Roadmaster's Report: The February 2013 Report was received.
