## East Donegal Township Board of Supervisors Meeting Minutes December 4, 2014

The regular meeting of the Board of Supervisors of East Donegal Township was held on Thursday, December 4, 2014 at 7:30 PM in the East Donegal Township Municipal Building, 190 Rock Point Road, Marietta, PA 17547.

The meeting was called to order by Supervisor Dennis J. Drager.

Supervisor Esbenshade led with a Prayer and Pledge to the Flag.

Brad Dunn, Honeysuckle Drive, inquired about the placement of four-way stop signs and speed bumps within the Castleton Development. The Board indicated that the placement of four-way stop signs is intended to assign right of way at certain intersections, not to control speeding. The placement of four-way stop signs is governed by PennDOT warrants that must be met. The Board also indicated that Township roadway specification do not permit the use of speed bumps. They have been used in situations in which the streets are to remain private and not dedicated to the Township.

The Board approved the minutes for November 6, 2014 and November 13, 2014, by a motion made by Mr. Esbenshade and seconded by Mr. Murphy. Discussion: None. Vote: Mr. Murphy; yes, Mr. Esbenshade; yes, Mr. Drager; yes. Motion carried.

A motion was made by Mr. Murphy and seconded by Mr. Esbenshade to approve the Treasurer's Reports for the Township and Maytown East Donegal Township Fire Department and approve the payment of all bills. Discussion none. Vote: Mr. Murphy, yes; Mr. Esbenshade, yes, abstaining from voting on check #48289; and Mr. Drager; yes, abstaining from voting on check #48310.

Mr. Drager acknowledged the receipt of the Balance Sheets for all Township Funds which were mailed to each Supervisor dated November 16, 2014.

Approved Ordinance 2014-3, amending Chapter 15, Motor Vehicles and Traffic, of the Code of Ordinances of East Donegal Township prohibiting the use of engine brake retarder brakes, providing for exemptions, establishing enforcement and penalties for violations. The Township is responsible for the installation and maintenance of required signage.

- C. Approved Resolution #2014-9 adopting the 2015 Fiscal Budget and establishing the Real Estate Tax Millage Rate for the Fiscal Year 2015 at 3.95 mills (.00395)
- D. Approved directing the Township Manager to advertise opening for part-time Park Supervisor position. It's hoped that the position is filled in time for the February meeting of the Township Park Commission and league representatives regarding the use of Township facilities.
- E. Approved Ordinance 2014-4 authorizing the participation of East Donegal Township in the PSATS Unemployment Compensation Group Trust pursuant to the Pennsylvania Intergovernmental Cooperation Law. The Township currently participates in the Trust, however, recent changes in the Trust's operating
- F. - G. Approved the requested Improvement Guarantee reduction for the Reserve at Union School, Phase 3, Final Subdivision Plan. The amount of the reduction recommended by D.C. Gohn Associates, Inc., and approved by the Board, is \$274,376.55. The new account balance would be \$213,859.00 to address outstanding item listed in the review letter prepared by D.C. Gohn Associates, Inc. and dated December 3, 2014.

- H. Approved Resolution #2014-10 authorizing the Township Manager to sign the Automated Red Light Enforcement Program Project Funding Agreement with the Pennsylvania Department of Transportation.
- Granted approval of the Final Subdivision Plan for Jay Kauffman, prepared by Light-Heigel & Associates, Inc., dated September 24, 2014, last revised November 20, 2014, and granted the following modifications to Township requirements:

Modification to Chapter 22, Part 3, Section 302. - Preliminary Plan Processing – To waive the required filing of a preliminary plan application.

Modification to Chapter 22, Part 6, Section 604. – Improvements to Existing Streets- To waive the requirement frontage improvements.

Modification to Chapter 22, Part 5, Section 503.1.1. – Roadway Improvements – To waive the requirement to improve existing streets at the perimeter of the development to current Township standards.

Modification to Chapter 28, Part 1, Section 307.C.1. – Swales– To permit swale side slopes of 3:1 instead of the maximum 4:1.

The approval of the Final Land Development Plan and the granting of ordinance modifications are subject to the following conditions (all references are to the Code of Ordinances of East Donegal Township, unless noted otherwise):

Compliance with the review comments outline by David Miller/Associates, Inc. in a review letter dated November 26, 2014.

All plan certificates shall be completed and appropriate seals affixed prior to submission of mylars for Township signature. (Chapter 22, Part 4, Section 403.3.F.)

The Applicant's written acceptance of the conditions within thirty (30) days from receipt of written notice of plan approval by the Township Board of Supervisors, on a form provided by the Township.

If the conditions are not accepted, the approval by the Board of Supervisors will be revoked, and the application will be denied for the reasons listed as conditions of approval of the Plan and ordinance modifications.

J. Approved the request of Township Manager for compensation for two (2) weeks of 2014 unused vacation time.
