The Board's Minutes of the East Donegal Township Board of Supervisors Held on January 5, 2015

The re-organization and regular meeting of the Board of Supervisors of East Donegal Township was held on Monday, January 5, 2015 at 5:00 PM in the East Donegal Township Municipal Building, 190 Rock Point Road, Marietta, PA 17547.

The meeting was called to order by Supervisor Dennis J. Drager.

Roll call of Supervisors: Present were Dennis J. Drager, Chairman; Allen D. Esbenshade, Vice Chairman; John Murphy, Member and Jeffrey Butler, Township Manager.

Public attendance is attached.

Supervisor Murphy led with a Prayer and Pledge to the Flag.

Re-Organization of the Board:

On a motion of Supervisor Drager, seconded by Supervisor Murphy, Mr. Jeffrey Butler was nominated Acting Chairman. The Acting Chairman called for nominations from the floor.

A motion was made by Mr. Murphy and seconded by Mr. Esbenshade to nominate Mr. Drager as Chairman, Mr. Esbenshade as Vice-Chairman, Mr. Butler as Secretary and Joyce Boyer as Treasurer for 2015. Vote: Mr. Murphy; yes, Mr. Esbenshade; yes and Mr. Drager; yes. Motion carried.

A motion was made by Mr. Murphy and seconded by Mr. Esbenshade to reappoint Marvin K. Nissley to the East Donegal Township Zoning Hearing Board for a three-year term until December 31, 2017. Vote: Mr. Murphy; yes, Mr. Esbenshade; yes and Mr. Drager; yes. Motion carried.

A motion was made by Mr. Murphy and seconded by Mr. Esbenshade to reappoint Robert Smeal for a five-year term until December 31, 2019. Vote: Mr. Murphy; yes, Mr. Esbenshade; yes and Mr. Drager; yes. Motion carried.

A motion was made by Mr. Murphy and seconded by Mr. Esbenshade to reappoint Keith L. Heigel for a five-year term until December 31, 2019. Vote: Mr. Murphy; yes, Mr. Esbenshade; yes and Mr. Drager; yes. Motion carried.

A motion was made by Mr. Murphy and seconded by Mr. Esbenshade to reappoint Michael Guinivan and David Houseal for four-year terms until December 31, 2018. Vote: Mr. Murphy; yes, Mr. Esbenshade; yes and Mr. Drager; yes. Motion carried.

A motion was made by Mr. Murphy and seconded by Mr. Esbenshade to reappoint Jacob G. Smeltz for a three-year term until December 31, 2017. Vote: Mr. Murphy; yes, Mr. Esbenshade; yes and Mr. Drager; yes. Motion carried.

A motion was made by Mr. Murphy and seconded by Mr. Esbenshade to approve the Treasurer's Reports for the Township and Maytown East Donegal Township Fire Department and approve the payment of all bills. Discussion none. Vote: Mr. Murphy, yes; Mr. Esbenshade, yes; and Mr. Drager; yes.

Mr. Drager acknowledged the receipt of the Balance Sheets for all Township Funds which were mailed to each Supervisor and dated November 17, 2014.

- 4) Craig Underwood as the East Donegal Township Zoning Officer and East Donegal Township Building Code Official.

A motion was made by Mr. Esbenshade and seconded by Mr. Murphy to appoint Matthew J. Creme, Jr., Nikolaus & Hohenadel, LLP, as Township Solicitor. Discussion none. Vote: Mr. Murphy, yes; Mr. Esbenshade, yes; and Mr. Drager; yes.

A motion was made by Mr. Murphy and seconded by Mr. Esbenshade to appoint Neil Albert as legal counsel for the Zoning Hearing Board. Discussion none. Vote: Mr. Murphy, yes; Mr. Esbenshade, yes; and Mr. Drager; yes.

A motion was made by Mr. Murphy and seconded by Mr. Esbenshade to appoint Jeffrey L. Butler as the voting delegate and Allen Esbenshade as the alternate voting delegate at the 2015 PSATS Convention on the dates of April 19 to April 22, 2015. Discussion none. Vote: Mr. Murphy, yes; Mr. Esbenshade, yes; and Mr. Drager; yes.

A motion was made by Mr. Esbenshade, seconded by Mr. Drager, to approve the following banks for the deposit of Township Funds.

- 1) An hourly rate of \$37.50/hour
- 2) Percolation Test Fees of \$250.00
- Additional Personnel charge of an hourly rate while conducting percolation testing of \$22.50/hour
- 4) Clerical \$18.00/hour
- 5) Mileage to be \$0.56/mile
- 6) Sewage Permit Fees
 - Single Family residential and multi-family residential sewage system \$135.00
 - b. Commercial, recreational, and institutional sewage system \$210.00
 - c. Holding tanks \$210.00

A motion was made by Mr. Murphy and seconded by Mr. Esbenshade to adopt Resolution 2015-2 appointing the Lancaster County Treasurer's Office as the Deputy Tax Collector of Real

Estate Taxes for the Township. Discussion none. Vote: Mr. Murphy, yes; Mr. Esbenshade, yes; and Mr. Drager; yes.

A motion was made by Mr. Murphy and seconded by Mr. Esbenshade to approve the 2015 wage schedule for Township Employees (attached). Discussion none. Vote: Mr. Murphy, yes; Mr. Esbenshade, yes; and Mr. Drager; yes.

A motion was made by Mr. Murphy and seconded by Mr. Esbenshade to establish the following Refuse and Recycling fees for 2015:

Refuse/Recycling Collection - \$190.00 per year. The fee will be billed as \$95.00 payable semi-annually.

Yard Waste and Grass Tags - \$1.00 each

Oversized Item Tags - \$3.00 each

Appliance Tags - \$12.00 per Appliance

Tire Tags - \$2.00 per Tire

Wheel tags - \$2.00 per Wheel

A motion was made by Mr. Murphy and seconded by Mr. Esbenshade to aprrove contracting Knaper's Stop and Go for the provision of Portable Toilets as follows: Two (2) located at the Maytown-East Donegal Township Fire House for Fuhrman Park, three (3) at Riverfront Park, one (1) at Legion Park, and one (1) at R&J Field, at the following rates:

Regular Unit w/Hand Sanitizer/Paper, 1x/Week Service - \$68.00 per month Handicap Unit w/Hand Sanitizer/Paper, 1x/Week Service - \$90.00 per month Discussion none. Vote: Mr. Murphy, yes; Mr. Esbenshade, yes; and Mr. Drager; yes.

A motion was made by Mr. Murphy and seconded by Mr. Esbenshade to adopt Ordinance 2015-1 amending Chapter 15, Part 4 (General Parking Regulations), Section 407. (Special Purpose Parking Zones Established; Parking Otherwise Prohibited) of the Code of Ordinances of East Donegal Township to delete one designated handicap parking space on West High Street and add one designated handicap parking space at 101 East High Street. Discussion none. Vote: Mr. Murphy, yes; Mr. Esbenshade, yes; and Mr. Drager; yes.

A motion was made by Mr. Murphy and seconded by Mr. Esbenshade to adopt Ordinance 2015-2 authorizing the participation of East Donegal Township in the Pennsylvania Townships Health Insurance Cooperative Trust pursuant to the Pennsylvania Intergovernmental Cooperation Law. Discussion none. Vote: Mr. Murphy, yes; Mr. Esbenshade, yes; and Mr. Drager; yes.

A motion was made by Mr. Esbenshade and seconded by Mr. Murphy to knowledge receipt of request from Nelson K. and Mary L. Ginder for property located at 508 Pinkerton Road, Mount Joy, PA 17552, be removed from the Urban Growth Area and authorize such request to be

forwarded to the Lancaster County Planning Commission and East Donegal Township Planning Commission for review and comment. Discussion none. Vote: Mr. Murphy, yes; Mr. Esbenshade, yes; and Mr. Drager; yes.

A motion was made by Mr. Murphy and seconded by Mr. Esbenshade to approve the Stormwater Management Plan for Elam Stoltzfus, prepared by Dawood Engineering, Inc., dated November 20, 2014, last revised December 16, 2014.

The approval of the Stormwater Management Plan is subject to the following conditions:

Compliance with the review comments outline by David Miller/Associates, Inc. in a review letter dated December 22, 2014.

All plan certificates shall be completed and appropriate seals affixed prior to submission of plans for Township signature.

The Applicant's written acceptance of the conditions within thirty (30) days from receipt of written notice of plan approval by the Township Board of Supervisors, on a form provided by the Township.

If the conditions are not accepted, the approval by the Board of Supervisors will be revoked, and the application will be denied for the reasons listed as conditions of approval of the Plan and ordinance modifications.

Project improvements are to be funded through a PennDOT Automated Red Light Enforcement Grant. Discussion none. Vote: Mr. Murphy, yes; Mr. Esbenshade, yes; and Mr. Drager; yes.

A motion was made by Mr. Esbenshade and seconded by Mr. Murphy to grant the request from Mount Joy Borough Authority for waiver of financial securities for site improvements for replacement of sewage pump station No. 2. Discussion none. Vote: Mr. Murphy, yes; Mr. Esbenshade, yes; and Mr. Drager; yes.

A motion was made by Mr. Esbenshade and seconded by Mr. Murphy to approve the Stormwater Management Plan for David I. and Sharon C. Watson, prepared by D.C. Gohn Associates, Inc., dated December 3, 2014.

The approval of the Stormwater Management Plan is subject to the following conditions:

Compliance with the review comments outline by David Miller/Associates, Inc. in a review letter dated December 18, 2014.

All plan certificates shall be completed and appropriate seals affixed prior to submission of mylars for Township signature.

The Applicant's written acceptance of the conditions within thirty (30) days from receipt of written notice of plan approval by the Township Board of Supervisors, on a form provided by the Township.

If the conditions are not accepted, the approval by the Board of Supervisors will be revoked, and the application will be denied for the reasons listed as conditions of approval of the Plan and ordinance modifications.
