- > 2019 Projected Total Revenue \$4,976,850.00
- > 2019 Projected Total Expenditures \$5,162,897.00
- > Reserves Needed To Balance Budget \$186,047.00
- ➤ Millage 3.1165 (No Change)
 - ❖1 Mill Equals \$655,831.60
 - ❖Assessment \$200,000 = \$623.30 Tax Bill



GENERAL FUND - REVENUE

- ✓ Real Estate Taxes
 - ➤ New Taxable Assessment \$663,133,300
 - Collected By Lancaster County Treasurer's Office
 - Projected Revenue From Property Tax -\$2,066,700.00
 - Represents Approximately 42% of Revenue



GENERAL FUND - REVENUE

- ✓ Local Tax Enabling Act (30% of Revenue)
 - > 2019 Earned Income Tax \$1,182,800.00
 - > 2019 Real Estate Transfer Tax \$180,000.00
 - > 2019 Local Services Tax \$125,000.00

- ✓ Interfund Transfers
 - Capital Reserve \$500,000
 - > Trash and Recycling \$100,000
 - ➤ Park and Recreation \$17,000

- ✓ PennDOT Grant \$147,200



EMPLOYEE WAGES - EXPENDITURES

- ➤ Wages for full-time and part-time employees represent \$472,150 (9% of the Township's General Fund expenditures)
 - No additional personnel
 - *3% wage increase for employees
