

The Board's Minutes of the East Donegal Township Board of Supervisors
Held on June 2, 2022

The regular meeting of the Board of Supervisors of East Donegal Township was held on Thursday, June 2, 2022, at 7:00 PM in the East Donegal Township Municipal Building, 190 Rock Point Road, Marietta, PA 17547.

The meeting was called to order by Vice-Chairman Esbenshade.

Supervisor Esbenshade led with a Prayer and Pledge to the Flag.

Roll call of Supervisors: Present were Vice-Chairman Allen D. Esbenshade and Supervisor Scott Kingsboro, and Jeffrey Butler, Township Manager. Thomas Jones, Chairman, was absent.

Ms. Bridey Hannold, 9 North River Street, inquired about the status of the on-line version of the Township Code of Ordinances and whether it was updated. She also indicated that the adopted fee schedule, as posted on the Township website, does not reflect some recent changes to fees adopted by the Board of Supervisors. She also inquired about Township Solicitor invoices on the agenda to be paid.

Ms. Hannold also expressed her opinion that the Board would not need to pass a motion to contribute to the Maytown Historic Society if the Treasurer's report and list of bills to be paid, that includes the contribution, is approved by the Board.

Ms. Hannold inquired if the action on the agenda regarding the International Construction Code has anything to do with the inter-municipal agreement for a Codes Appeal Board. She stated that the Township's selection of a third-party inspector different from the rest of the municipalities reflects poorly on the Township.

The Board approved the minutes for the May 5, 2022 regular meeting of the Board of Supervisors, by a motion made by Mr. Kingsboro and seconded by Mr. Esbenshade. Discussion: None. Vote: Mr. Kingsboro; yes, and Mr. Esbenshade; yes. Motion passed.

A motion was made by Mr. Kingsboro and seconded by Mr. Esbenshade to approve the Treasurer's Reports for the Township and approve the payment of Township bills. Discussion: none. Vote: Mr. Kingsboro; yes, and Mr. Esbenshade; yes. Motion carried.

Mr. Esbenshade announced that the conditional use application of Randall Wolgemuth for property at 450 Pinkerton Road has been rescheduled to Wednesday, June 15, 2022 at 6:30 pm.

New Business.

Resolution 2022–6, Resolution Requesting To Name The PA Route 772 Bridge Over Donegal Creek The Kenneth C. Depoe Bridge.

A motion was made by Mr. Kingsboro, and seconded by Mr. Esbenshade, to adopt Resolution 2022-6 requesting that the Pennsylvania General Assembly name the bridge on PA Route 772 that crosses over the Donegal Creek, the Kenneth C. Depoe Bridge.

Mr. Frank Splain inquired about the content of the sign to be placed at the bridge and whether Donegal Fish & Conservation Association would be included. If the request to name the bridge in honor of Mr. Depoe is approved by the legislature, the content of the sign would be determined by PennDOT. Vote: Mr. Kingsboro, yes and Mr. Esbenshade, yes. Motion passed.

Consideration of 2018 Edition of the International Construction Code and Permits for the Installation of Photovoltaic Solar Arrays.

A motion was made by Mr. Kingsboro, and seconded by Mr. Esbenshade, to authorize the publication of the required public notice regarding an ordinance amending the Township Code of Ordinances to reference the 2018 edition of the International Construction Code and to require permits to be obtained for the installation of photovoltaic solar panel installations.

Discussion: None. Vote: Mr. Kingsboro, yes and Mr. Esbenshade, yes. Motion passed.

Copies of the May 2022 Zoning/Building Report were provided to the Board. For the month, 13 Zoning Permits and 6 UCC Permits were issued. The total value of construction authorized equaled \$497,902.00. Permit fees collected totaled \$7,314.25.00. There were 14 zoning inspections and 40 UCC inspections conducted in the month.
