# The Board's Minutes of the East Donegal Township Board of Supervisors Held on January 3, 2023

The organization/regular meeting of the Board of Supervisors of East Donegal Township was held on Tuesday, January 3, 2023, at 5:00 PM in the East Donegal Township Municipal Building, 190 Rock Point Road, Marietta, PA 17547.

The meeting was called to order by Supervisor Esbenshade.

Supervisor Esbenshade led with a Prayer and Pledge to the Flag.

Roll call of Supervisors: Present were Supervisor Allen D. Esbenshade and Supervisor Scott Kingsboro. Jeffrey Butler, Township Manager was also present.

Public attendance is attached.

A motion was made by Mr. Kingsboro and seconded by Mr. Esbenshade to accept the resignation of Supervisor Tom Jones from the Board of Supervisors. Vote: Mr. Esbenshade; yes, and Mr. Kingsboro; yes. Motion carried.

Mr. Esbenshade announced that the Board will be accepting letters of interest and resumes from Township residents interested in serving on the Board of Supervisors. The appointment would finish the term of Mr. Jones that ends December 31, 2023. Letters of interest should be submitted to the Township office by noon, Friday, January 20, 2023.

## Re-Organization of the Board:

On a motion of Supervisor Kingsboro, seconded by Supervisor Esbenshade, Mr. Butler was appointed Temporary Chairman. Mr. Butler called for nominations from the floor.

A motion was made by Mr. Esbenshade and seconded by Mr. Kingsboro to nominate Mr. Kingsboro as Chairman. Vote: Mr. Esbenshade; yes, and Mr. Kingsboro; yes. Motion carried.

A motion was made by Mr. Kingsboro and seconded by Mr. Esbenshade to nominate Mr. Esbenshade as Vice-Chairman. Vote: Mr. Kingsboro; yes, and Mr. Esbenshade; yes. Motion carried.

Mr. Butler relinquished position of Chairman to Supervisor Kingsboro.

A motion was made by Mr. Esbenshade and seconded by Mr. Kingsboro to approve the following reappointments to Township Boards and Commissions:
