The Board's Minutes of the East Donegal Township Board of Supervisors Held on April 6, 2023

The regular meeting of the Board of Supervisors of East Donegal Township was held on Thursday, April 6, 2023, at 7:00 PM in the East Donegal Township Municipal Building, 190 Rock Point Road, Marietta, PA 17547.

The meeting was called to order by Chairman Kingsboro.

Supervisor Esbenshade led with a Prayer and Pledge to the Flag.

Roll call of Supervisors: Present were Chairman Scott A. Kingsboro, via conference telephone call, Vice-Chairman Allen D. Esbenshade and Supervisor Michael L. Brubaker. Township Manager Jeffrey Butler was also present.

Mr. Esbenshade chaired the meeting for Mr. Kingsboro.

Mr. Esbenshade opened the meeting for public comment on items not on the agenda. None were heard.

The Board approved the minutes for the March 2, 2023 regular meeting of the Board of Supervisors and the March 21, 2023 work session, by a motion made by Mr. Kingsboro and seconded by Mr. Brubaker. A motion was made by Mr. Brubaker and seconded by Mr. Kingsboro to approve the Treasurer's Reports for the Township and approve the payment of Township bills. Discussion: none. Vote: Mr. Brubaker: yes, abstained from vote on check #52698, Mr. Esbenshade; yes, abstained from vote on check #52679, and Mr. Kingsboro; yes, abstained from vote on check #52756. Motion carried.

Resolution 2023-5 Approving Contract Change Order for Chickies Creek Day Use Area Improvements, Phase I Project

A motion was made by Mr. Kingsboro, and seconded by Mr. Esbenshade, to adopt Resolution 2023-5 approving contract Change Order 1 for an increase in the amount of \$12,916.00 for the Chickies Creek Day use Area Improvements, Phase I Project.

Mr. Butler indicated that additional work is needed to address a sinkhole that was encountered during construction of the parking lot. Vote: Mr. Brubaker; yes, Mr. Esbenshade, yes; and Mr. Kingsboro, yes. Motion passed.

Resolution 2023-6 Approving Contract Change Order for Evans Run Streambank Restoration Project

A motion was made by Mr. Brubaker, and seconded by Mr. Kingsboro, to adopt Resolution 2023-6 approving contract Change Order 1 for an increase in the amount of \$25,000.00 for the Evans Run Streambank Restoration Project.

Mr. Butler indicated that enhanced streambank protection will be provided with the installation of the additional material. Vote: Mr. Brubaker; yes, Mr. Esbenshade, yes; and Mr. Kingsboro, yes. Motion passed.

A motion was made by Mr. Kingsboro, and seconded by Mr. Brubaker, to award the contract for the replacement of firehouse concrete steps and installation of concrete pad, to SM Johns & Son, for \$12,557.00 based on proposal dated March 2, 2023.

Junior High 5k Fun Run - Saturday, May 13, 2023

Request For Use of Riverfront Park - Juvenile Diabetes Research Foundation

A motion was made by Mr. Kingsboro, and seconded by Mr. Brubaker, to approve the request of the Juvenile Diabetes Research Foundation for the use of Riverfront Park for an awareness event and fun ride on Sunday, July 9, 2023, (rain date July 30, 2023) from noon to 3:00 PM, subject to submission of the appropriate certificate of insurance.

Firehouse Expansion Loan Payoff

A motion was made by Mr. Brubaker, and seconded by Mr. Kingsboro, to approve a donation to satisfy loan secured by the Maytown East Donegal Township Fire Department for the expansion of the firehouse in an amount not to exceed \$420,000.00 plus associated fees.

Mr. Kingsboro stated that the loan was secured by the Maytown East Donegal Township Fire Department in 2015 to undertake the expansion of the firehouse. Rising interest

rates have greatly increased the monthly payment on the loan. Vote: Mr. Brubaker; yes, Mr. Esbenshade, yes; and Mr. Kingsboro, yes. Motion passed.

2023 Township Scholarship Program

Mr. Butler stated that information has been provided to the Donegal School District regarding the 2023 Township Scholarship Program that awards \$1000 to a graduating East Donegal Township student. It's proposed that the Board of Supervisors will announce the scholarship winner at the May 4, 2023 meeting of the Board.

Copies of the March 2023 Zoning/Building Report were provided to the Board. For the month, a total of 15 permits were issued (8 Zoning Permits, 3 UCC Permits and 4 combination Zoning/UCC Permits). The total value of construction authorized equaled \$252,410.00. Permit fees collected totaled \$9,889.00. There were 42 zoning inspections and 25 UCC inspections conducted in the month.
