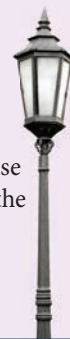

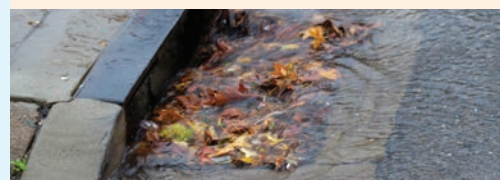

Storm Drains and keeping them free of debris



Storm water becomes a problem when it picks up debris, chemicals, dirt, trash and other pollutants. Storm water travels through a system of pipes and road side ditches that make up the storm sewer systems. It eventually flows directly to a lake, river, stream, wetland or coastal water. All of the pollutants storm water carries along the way also empty into the waters because storm water is not treated.

Grass clippings and leaves are very common pollutants in the storm drains. Please refrain from allowing your grass or any other pollutants (including water from swimming pools) to enter the storm drains. Reminders will be sent to residents throughout the year wherever there are excess amounts of pollutants entering the storm drains.

This recommended date and time will not be changed, altered, or cancelled, for any reason.

Participation in Trick or Treat is voluntary and as such participants should make decisions based on their personal comfort level, including the possibility of inclement weather.

TRASH SCHEDULE

Tuesday trash day- all roads west of Colebrook Road and Old Colebrook Road

Wednesday trash day – all roads east of Colebrook Road including Colebrook & Old Colebrook Roads.

Occasionally the trash will be delayed a day or cancelled until the following week. If the trash is to be picked up the following week, double the amount of normal trash may be put out for pick up. Anyone signed up to receive Township e-mails will be notified by e-mail of any changes.

Missed Pickups

If your trash/recycling or yard waste is missed call the office 717-426-3167 asap. If you are calling after hours leave a message. If your trash was not out when the trucks went by it is NOT considered a miss.

APPLIANCE/TIRE PICKUP

OCTOBER 24 & 25 ON YOUR TRASH DAY

Tags for appliances and tires are purchased at the Township Office. Appliances (washers, dryers, stoves, dishwashers, freezers, refrigerators, dehumidifiers, air-conditioners, hot water heaters, etc.) are \$15.00 each. Tire tags are \$4.00 each. Rims are \$4.00 each. When purchasing a tag, you will need to give your street address and identify the item you are putting out for pickup. Appliances/tires must be out the night before the designated pickup date.

Public Works Reminders:

TREES, SHRUBS, PLANTS & OTHER ROADWAY OBSTRUCTIONS

The Township's streets, alleys and rural roads must maintain proper clearance along and above the roadway in order to: 1) insure the safety and welfare to the traveling public and 2) to prevent damages to Township vehicles or equipment used to maintain the streets. It is the responsibility of property owners to maintain their trees or vegetation that has grown beyond the edge of the roadway. Utilize this information and these drawings to insure that your property meets the clearance regulations.

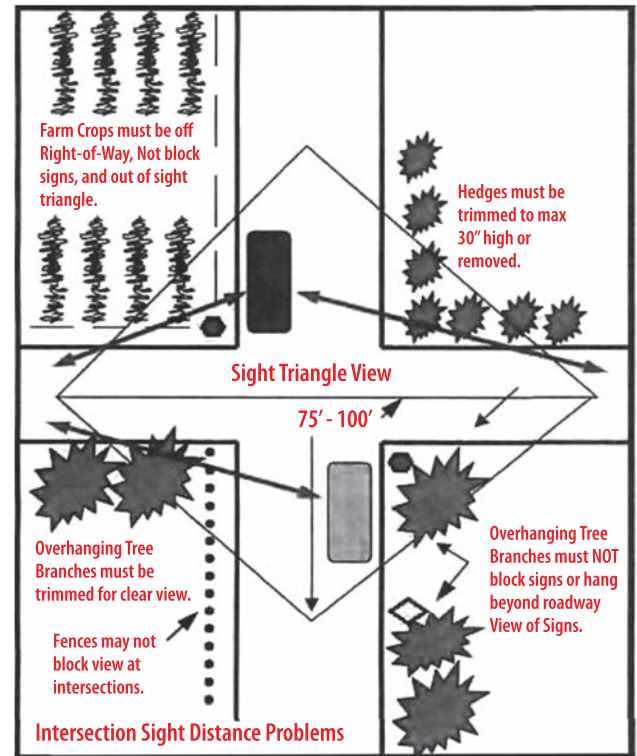
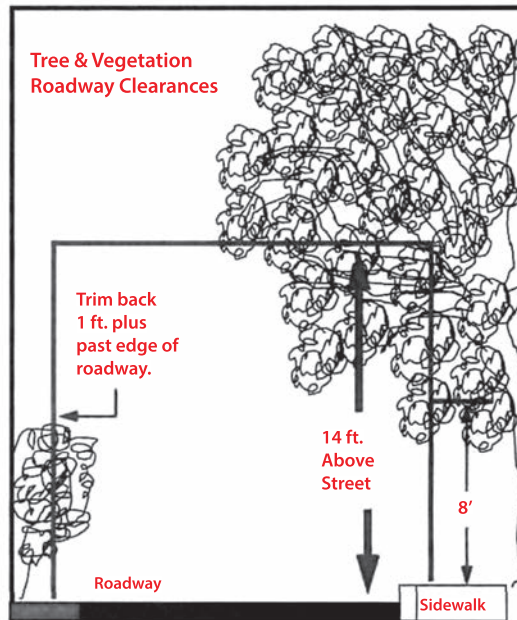
Sight Distance Problem

Under the Pennsylvania Vehicle Code - Section 6112, Removal of traffic hazards by Property Owner, the following is listed: "It is the duty of the owner of the real property to remove from the property any tree, plant, shrub, or other similar obstruction, or part thereof, which by obstructing the view of any driver constitutes a traffic hazard."

Roadway Clearance Problem

The trees or vegetation have grown beyond the edge of the roadway and/or overhanging trees are lower than the minimum 14-foot height above the roadway. This problem is a safety concern to the driving public, causing motorists to drive out of their lane of traffic. This is a liability in the event an accident should occur.

Damage to vehicles hitting tree limbs and other vegetation is also a concern. The Township's plowing and curbside collections require the trucks and equipment to drive along the curbside or edge of the road and must clear all overhanging trees and bushes. Property owners, who do not maintain tree and vegetation overgrowth, to the Township's specifications, run the risk of receiving a violation notice from the Township.



Township Awarded National Fitness Campaign Grant for Outdoor Fitness Court

East Donegal Township has been awarded a \$30,000 grant for the installation of a free-to-the-public fitness court. The grant award is part of a nationwide effort of the National Fitness Campaign to install and activate over 200 outdoor fitness courts in cities and schools. The fitness court features a 32-foot-by-35-foot outdoor bodyweight circuit training system with 30 pieces of body-weight fitness elements, including seven full-body circuit training stations and a body-weight training wall.

All Fitness Courts are supported by a free to download mobile application, which offers world-class workouts and acts like a coach in your pocket, serving up fun ways to stay fit while enjoying fresh air, sunshine and a healthy workout outdoors.

Installation of the fitness court, planned to be located within Fuhrman Park on Rock Point Road, is expected to begin early spring 2024. Be sure to check the Township website for updates and the events celebrating the project's completion.



Permit Reminders:

Zoning permits are required for buildings, demolition, porches, patios, decks, sidewalks, roof extensions, fences, sheds, swimming pools, additions, alterations, renovations, in-home businesses and changes of use, etc. PA Construction Code Permits may also be required for the preceding list and some repairs. Check with the Township Zoning Officer prior to any construction, alterations or repairs. **Final Inspections** are required as the last step in the permitting process for both Zoning permits and Construction Code Permits. A Certificate of Use and Occupancy will be issued after an approved final inspection. Structures may not legally be occupied or utilized without a Certificate of Use and Occupancy. Call the Township Office at 717-426-3167 to arrange for a final Zoning/Construction Inspection.

Filing of Zoning Ordinance Complaints

East Donegal Township receives frequent calls, letters, emails, and verbal complaints about possible Zoning Ordinance violations within the Township. Among these are many anonymous complaints, of which the staff will NOT investigate.

Chapter 27, Part 11, Section 1102.C. of the Township Code of Ordinances addresses the procedure for complaints regarding violations of zoning regulations and reads as follows:

C. Complaints regarding violations. The Zoning Officer may, and, when in receipt of a signed written complaint stating fully the cause and basis thereof, shall, investigate alleged violations of this Chapter.

In order to investigate, the person making the complaint must provide the address and / or tax parcel number of the property where the alleged violation is taking place. In addition, complaints that are mailed in or presented at our Township office must be signed and provide contact information so the Township can verify this is actually the person making this specific complaint.

American Legion Auxiliary Unit #809

The Maytown American Legion Auxiliary Unit #809 began selling dedication bricks in 2019 to replace the cement sidewalk in the Maytown square. The ALA had the bricks engraved with the names submitted by the person purchasing the brick to honor someone. On Memorial Day 2023, the ALA purchased and dedicated 9 bricks to honor men who were killed in action during WWII. Dr. Richard Albright JR donated 4 hand forged iron lanterns suspended from the trellises at the entrances to the square. They were dedicated in memory of his father Richard Albright Sr who was killed in France in 1944. In June, ALA Unit #809 President Sara Gutshall attended and presented 2 Americanism awards at the Donegal Jr High School. Rose Zurin and Derek Baystaff received those awards. The mission of the ALA is to honor Military, Veterans and Citizens for their service to God, Country, and Community. In August the ALA treated the Maytown/East Donegal Township to pizza for their community service. We would like to remind everyone that Election Day is November 7. Please Vote.

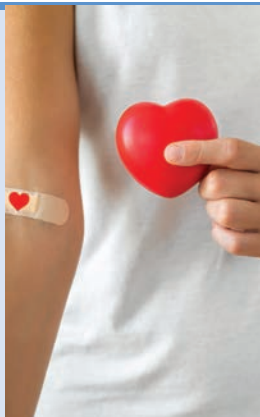

Notes on Recycling: 2023

- Place recycling curbside the night before you designated pickup day.
- Make sure your container is marked recycling.
- Place the container curbside where it is easily visible.
- The only items to be placed in the bin are as follows:
 - o Corrugated Cardboard:
 - NO pizza boxes
 - Dry packing and shipping boxes with fluted sheet
 - o Plastic Bottles and Jugs.
 - Only plastic with a neck.
 - No bottles or jugs used for poisonous material.
 - o Metal Food and Beverage cans
 - Aluminum or tin
 - o Glass Food and Beverage Bottles and Jars
 - Clear, green or brown
- Items must be emptied and rinsed out.
- Do not leave any recyclables outside of the bin.
- NO plastic bags in the bin for any reason.
 - o Recycle clean, dry plastic bags at the grocery store.
- No other materials than listed are to be in the bin.
- Flatten cardboard (no grease or food on boxes, no wet boxes)
- There is a cardboard dumpster at the Township Building for corrugated cardboard only.
- Do not put recycling out if high winds.



PLEASE NOTE:

The following items do NOT belong in the bin and are considered trash: Newspaper or any paper, cereal boxes, clam shells, Styrofoam, polystyrene, deli containers, dishes, egg cartons, toys, hangers, hoses, flowerpots (some with plants still in them), coffee makers, pool cover, box fan, carpet, books, pillows, blinds, shelving, broken plastic chair, yard waste, drinking glasses, vases, plastic cups, toaster, plastic wrap, fast food containers, aluminum foil, disposable pie tins, construction material. These are all unacceptable items that were recently noted in recycling bins in East Donegal Township. *For as much as we want you to recycle, we have to say don't contaminate the recycling process: **When in doubt, throw it out.**

Litter:

Decomposition is a term scientists use to describe how materials break down in nature

- Paper: 2 to 4 weeks
- Plastic coated paper: 5 years
- Plastic bags: 10 to 20 years
- Plastic bottles: Indefinitely
- Plastic six pack holders: 100 years
- Orange or banana peels: 2 years
- Aluminum cans: 80 to 100 years
- Styrofoam: Indefinitely
- Tin cans: 50 years
- Nylon fabric: 30 to 40 years
- Cotton shirt: 1-6 months
- Glass bottles: 1,000,000 years
- Wool socks: 1-5 years



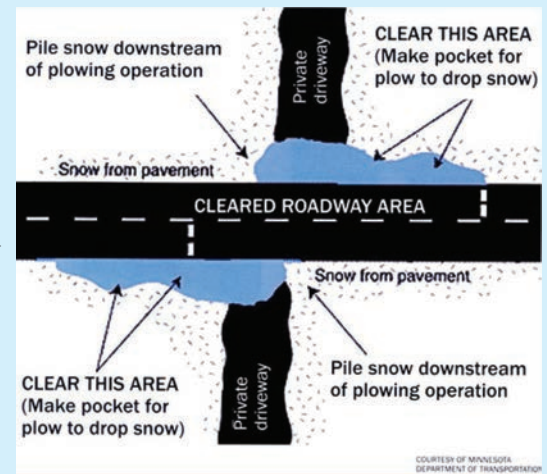


WINTER MAINTENANCE

Before we know it, winter will be upon us. Winter brings the potential for snow; homeowners can assist the Public Works Department to provide an improved level

of service by observing the following guidelines:

- Do not park vehicles on the street until the street has been completely cleared off. Note that the Township, in most cases, will plow the street two separate times. The first time will be to clear an access to the primary roads, and the second pass will push the snow back to the edge of the street.
- Wait until the street is plowed before clearing driveway openings.
- Never shovel snow out into the streets.
- Shovel out fire hydrants if they are located on your property.
- Motorists should be aware of Township vehicles salting or plowing snow. Motorists should not interfere or impede the plow in any way.
- Remove the snow or ice from your sidewalk within 24 hours after the cessation of any fall of snow, sleet, or freezing rain.
- Make sure mailboxes are properly secure.
- Do not try to pass a snow plow.
- Basketball Poles/Nets: Basketball poles are not acceptable items within the Township right-of-way. As an unapproved structure within the legal right-of-way, the following applies:



- East Donegal Township will not pay for any damage to basketball poles, nets or any other recreational equipment located within the public right-of-way that is damaged by plowed snow or struck during plowing operations.
- East Donegal Township will seek full payment for any damage to salting/plowing equipment caused by recreational equipment located within the public right-of-way.

Trash Notes:

- Place trash curbside the night before your designated pickup day.
- Place trash where it is easily visible for pickup.
- Trash is limited to **three (3)** bags per week.
 - Maximum 32 gallon/30 pounds per bag.
- Additional bags must be tagged as extra trash (\$1.00 per bag)
- Bags over 32 gallons or weighing more than 30 lbs. must have a bulk item tag (\$5.00)
- Larger items must have a bulk item tag (\$5.00 each item)
 - Call to find out if the item is acceptable.
- No construction debris is permitted in the trash.
- No yard waste is permitted in the trash during yard waste pickup schedules.
 - Yard waste is to be in brown bags with \$2.00 tags on each bag.
- **NO** burning of yard waste or trash at any time.
- Appliance/Tire pickup is twice a year.
 - Appliances \$15.00, tires \$4.00, rims \$4.00
- All special pickups (Christmas trees, yard waste, appliance/Tire) are scheduled on your trash day.

If your trash or recycling is missed call the office at #717-426-3167 as soon as you realize it was missed. If you are calling after hours leave a message. If your trash or recycling was not out when the trucks went by it is NOT considered missed.

Household Hazardous Waste

The following items are not permitted in the trash and are accepted (no fee for county residents) at the HHW facility: adhesives, automotive fluids such as motor oil, antifreeze, etc. (5 gallon containers-max), batteries, chemistry sets, cooking and frying oils, *covered devices (desk top computers, laptops, monitors, computer peripherals (keyboard, mouse, printer, and speakers), televisions, and e-readers, *E-waste photo cameras, video cameras, cell phones and smart phones, cell phone peripherals (chargers, batteries, Bluetooth earpiece, air cards, clips, cases), DVD and VCR players, MP3 players and iPods, PDA's, portable electronic game players, video and game consoles, stereos and stereo peripherals (CD players, turntables, amplifiers, speakers) NO wooden speakers. Limit of 10 e-waste items per customer per day, fire extinguishers, floor and furniture polish, Fuel: kerosene, gasoline, propane, household cleaners, lawn treatments: herbicides, pesticides, Mercury containing items (ballasts, fluorescent bulbs, thermostats and thermometers), paint, rust inhibitors, stains, turpentine and thinners, Photographic and pool chemicals. Prevent Stormwater Pollution During Winter Months

Be careful with your salt application and consider alternative salting methods. Road salt can be harmful to plants, aquatic life and drinking water supplies. Salt alternatives such as potassium acetate (KA), calcium magnesium acetate (CMA), or sand are less damaging to homes and landscaping, and can be used to de-ice and improve traction on a walkway or driveway. If you do apply salt, shovel first then apply as little as possible.

Rethink rinsing your garage floor. While it is tempting to take a hose and wash the gray sludge and salt off of your car and out of your garage on a mild winter day, don't do it! Residue left from road salt, oil, gas and other pollutants drip from your car and end up on your garage floor. Your garage runoff most likely drains into a storm sewer drain, ditch, river, or lake. This means you are flushing pollutants right into streams and eventually into the Chesapeake Bay. One alternative is to clean your car by taking it to a commercial car wash where the drains should flow to a wastewater treatment facility. A clean car means a cleaner garage.

Watch your pet waste. Picking up after a pet is just as important in the wintertime as it is in the warmer months. Animal waste can be a significant source of harmful bacteria and disease. Cooler temperatures and frozen soil slow down the decay process. When the snow finally does melt, you will have a very unpleasant surprise waiting for you.

Cover bare soil. If you are doing earthwork in the winter, remember to maintain your construction site erosion and sediment control practices to keep soil and other

pollutants on your site and out of streams. Late water thaws & saturated soil conditions can lead to a very muddy spring. Be prepared and maintain erosion and sediment control practices all winter long. Plant ground cover on bare areas to prevent soil erosion. If you have questions on what you can do to reduce water pollution in the winter months, contact your local Soil & Water Conservation Districts.



Carbon Monoxide- the Silent Killer

There are numerous potential sources of carbon monoxide in your home: furnaces, water heaters, clothes dryers, space heaters, stoves, fireplaces, wood stoves, charcoal grills, and automobiles. Exposure to high concentrations can cause death in just a few minutes. Carbon monoxide is often referred to as the "Silent Killer" because it is colorless, odorless and tasteless, making it almost impossible to detect. The symptoms of carbon monoxide poisoning can be very vague, and often involve many of the body's systems. Immediate diagnosis is critical. Exposure to CO can cause flu-like symptoms such as headaches, nausea, and dizziness, burning eyes, confusion, drowsiness and even loss of consciousness and even death.

At any time, if you or anyone else in your home is experiencing the symptoms of CO poisoning, get everyone out of the house and seek medical help. Call 911 or your local fire department.
