Kitchen and restroom areas must be cleaned and returned to original condition at the end of the reservation. Refundable key deposit of \$50.00 is required for this rental.
- Pavilion reservations are not considered confirmed until East Donegal Township has received a completed reservation form and all applicable rental fees.
- To help maintain the pavilion in a clean and welcoming condition for all visitors, renters are responsible for removing all trash and personal items at the conclusion of their reservation.
- All pavilion rental fees are non-refundable, regardless of weather conditions, utility interruptions, Acts of God, emergencies, or any other event or circumstance beyond the control of East Donegal Township.

**CHAPTER 16, PARKS AND RECREATION**  
**PART 1, USE OF PARKS AND RECREATION FACILITIES**

**§103. Prohibited Conduct.**

No person in attendance at the park shall:

- A. Injure deface, remove, cut or damage any of the trees, plants, shrubs, turf, buildings, structures, signs, fixtures or any other property of the Township.
- B. Litter any area of the park with garbage, paper, bottles, cans or other waste material; nor dump or dispose of same in any manner except in receptacles designated for such purposes.
- C. Kindle or maintain any fire except in fireplaces, picnic stoves or other areas specially designated for such purposes and located by the Park Commission or Supervisors.
- D. Remove any bench, seat, table or other appliance without permission of the Park Commission or Supervisors.
- E. Set up any booth, table or stand for the sale of any property or service whatsoever within the limits of a park without the permission of the Park Commission or Supervisors.
- F. Distribute, sell, service or rent any services or properties within the limits of a park without the permission of the Park Commission or Supervisors.
- G. Solicit for any purpose in a park without the permission of the Park Commission or Supervisors.
- H. Operate, use, stop or park any vehicle (excluding commercial vehicles providing authorized services and including, without limitation, motor vehicles, motorcycles, minibikes, recreational vehicles and snowmobiles), bicycle, skateboard or other means of conveyance except in areas where permitted or designated by the Park Commission or Supervisors; or operate same in a reckless or negligent manner or in excess of any posted speed limit or in such a manner as to become a nuisance to other park users or persons in the Township.
- I. Bring onto park premises, possess or consume any alcoholic beverage or illegal drugs of any kind.
- J. Carry or discharge any firearms, slingshots, firecrackers, fireworks, or other missile propelling instruments or explosives or arrows, or other dangerous weapons that have such properties as to cause annoyance or injury to any person or property, unless permission has been granted by the Park Commission or Supervisors; police officers in the performance of their duties will be exempt from the provisions of this Subsection J.
- K. Hunt for, capture or kill, or attempt to capture or kill, or aid or assist in the capturing of or killing of, in any manner, any bird or animal of any description, either game or otherwise, and to that end, it is unlawful for any person to carry onto or possess in a park a shotgun, rifle, pistol, bow and arrow, slingshot or firearm or missile propelling instruments of any make or kind, unless specific permission is granted by the Park Commission or Supervisors; police officers in the performance of their duties will be exempt from the provisions of this Subsection K.
- L. Allow pets to run loose or to be controlled by a leash longer than six feet, or fail to remove or otherwise dispose in waste receptacles the feces or other animal waste left by a person's pet or animal.

- M. Disturb the peace by any conduct so as to annoy any other person using a park or in the Township.
- N. Use a tennis court for more than one hour when there are other persons waiting to use such court.
- O. Hold any public meeting or rally, or engage in any marching or driving as members of a military, political or other organization, without permission of the Park Commission.
- P. Make additions to park property or grounds unless same has been approved by the Park Commission and the Supervisors.
- Q. Gamble in any manner.
- R. Write, paint, post, display, distribute or otherwise affix any graffiti, banner, poster, sign or sticker of any nature (including but not limited to, personal, commercial or political) on any tree, shrub, building, structure, equipment, facility or any other property in a park without the express permission of the Park Commission or Supervisors.
- S. Recklessly, carelessly or unsafely ride, operate or otherwise use any motorized or nonmotorized equipment, toy, vehicle or other personal property, including but not limited to, automobiles, motorcycles, scooters, bicycles, tricycles and skateboards.
- T. Hit golf balls or play golf except where specifically permitted by signs, the Park Commission or the Supervisors.
- U. Ride, operate or otherwise use any motorized or nonmotorized equipment, toy or vehicle on any soccer, softball, baseball, basketball, tennis or other playing field, court or surface.
- V. Injure, deface, destroy, obstruct or remove any notice, sign, poster, rule or regulation posted at any place in or about any park by the Park Commission or the Supervisors.
- W. Clean, polish, grease, lubricate or make repairs to any vehicle except those of a minor nature and then only in cases of emergency.
- X. Leave a vehicle in any park after closing hours without the permission of the Park Commission or Supervisors. And if such occurs, the Township shall be under no obligation to reopen the park or any parking lot, road or gate after closing hours in order to allow removal of such vehicle during a time when the park is closed.
- Y. Engage in any unlawful or illegal conduct or behavior.
- Z. Disobey an order of a police officer or any member of the Park Commission or Supervisors, or disobey, disregard or fail to comply with any rule or regulation, warning, prohibition, instruction or direction given by the Park Commission or any of its authorized members, or any Supervisor.
- AA. Smoke any cigarette, cigar, pipe, or any other thing in a park, including without limitation all baseball fields, soccer fields, tennis courts, tot lots, playgrounds, play areas, swimming pools, buildings, pavilions, parking lots (including without limitation the parking lot of the Maytown-East Donegal Township Fire Company, which parking lot is utilized by the users of the adjacent park), and all other structures and recreational areas in a park.
